


Our Transactional Services

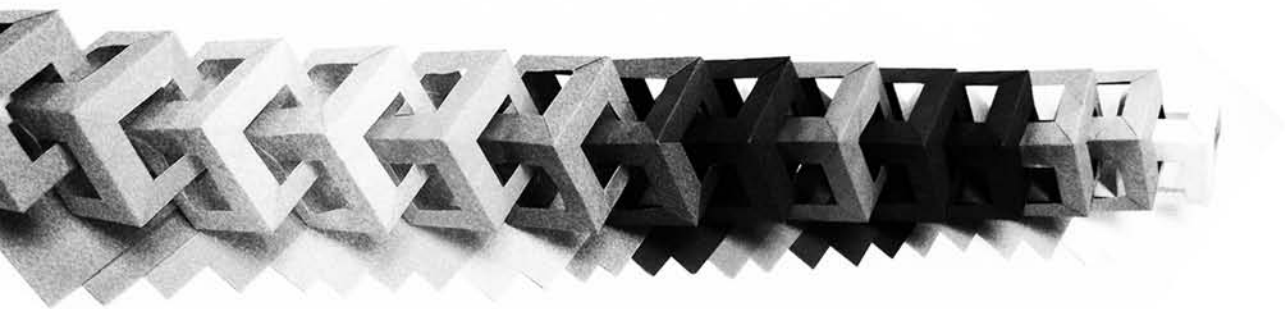
